**Old Business:** Dan is to look into the letter for Midday Embroidery for a sponsorship towards the League and give it to Dave D.

Dan brings up the attendance levels of certain members of this Executive, the rule 2.2.9 governors what the attendance level can not get below. Dan does acknowledge that the President is the person that has to enforce this rule and John has or will talk too the members in question, it is not up to Dan (Secretary) to enforce this rule.
